

3| Test and certification conditions

Registering for the Siemens AG Low Voltage Certification Program gives you the opportunity to complete a test in this field designed by Siemens AG and, assuming you pass the test, to obtain a corresponding certificate issued by Siemens AG. Successfully completing the certification test allows you to use the title "Siemens Certified Expert for 3WL air circuit breaker" with the corresponding certificate. You can use the certificate for commercial purposes in accordance with the conditions set out below.

The test is organized as specified in the test regulations attached as Document 4. Your registration for the test signals that you accept the rules defined in the test regulations and will abide by them.

3

Siemens AG will issue the corresponding certificate to you on successful completion of the certification test. You are authorized to use the title indicated on the certificate for commercial purposes for a period of four (4) years from the date of issue. This right cannot be transferred to other people.

4

The title applies only to you as an individual, so it must not be used in a way that might create the impression that a company you manage is certified. It is likewise prohibited for your employer to associate your title with his/her company in a way that might create the impression that the company is certified.

You must not use the title acquired through the certificate for commercial purposes if the certificate has expired and/or been revoked by Siemens AG, without first successfully completing the certification test again and thereby regaining the right to use the title.

Certification does not convey any right to provide training independently in the name of or on behalf of Siemens AG or to distribute certificates in the name of or on behalf of Siemens AG or to distribute training materials.

7

All rights to brands and logos of Siemens AG are retained by Siemens AG and their use is permitted only by contractual agreement.

8

Siemens AG may revoke the certificate if you commit acts or omissions contrary to the purpose of the certificate, which is to generate trust among customers. Specific instances in which Siemens may revoke the certificate include the following:

- You are using the title acquired through the certification process in a manner incompatible with the rules set out above
- Your actions or statements are harming the image of the Siemens Group or of its staff (this applies in particular if repeated poor service performance on your part impacts negatively on the reputation of the products and services of the Siemens Group)
- You repeatedly make inaccurate statements about products and services of Siemens AG to third parties
- You tamper with Siemens products. Siemens AG may also require you to pay compensation if your certificate has to be revoked for the reasons set out above.

If your certificate is revoked, you must return the document to Siemens AG without delay.

Siemens AG may change the conditions of the Siemens Low Voltage Certification Program at any time. Certificates already issued will be unaffected by any changes for the duration of their validity period.

The costs for the certification test (LV-CERT) are shown separately. Further information on prices can be obtained via your Siemens training provider. The test registration is binding and obliges the participant to meet the costs incurred.

If you intend to take the test, you must consent to the use and storage of your personal data. If you do not give this consent, you will not be able to complete the test and will therefore have no entitlement to receive a certificate. Siemens AG may revoke your certificate if you subsequently withdraw your consent for the use and storage of your personal data entirely such that Siemens AG can no longer store your certificate data and Siemens AG and its Group companies are no longer able to provide information about your certification to third parties. Revocation triggers the legal consequences defined above.
